The Pandemic Institute "Rapid Response" Fund: Application Guidance

This funding call is only eligible to The Pandemic Institute investigators – see eligibility requirements for further details.

Scope

The Pandemic Institute (TPI) Rapid Response Fund is supporting new research and other opportunities to tackle emerging infections and future pandemic threats. Proposals submitted must be urgent, with rapid activation, to enable early and valuable outcomes to be established and/or to access time-dependent resources.

The aim of the investment is to support unique, time-limited opportunities that demonstrate a need for a rapid commissioning process to be followed.

Application Process and Timeline

Applications are accepted on a rolling basis. If you would like your proposal to be considered for TPI Rapid Response Fund, please submit a proposal. This can be accessed via an online survey: https://app.onlinesurveys.jisc.ac.uk/s/liverpool/rapid-response

Please note – you are strongly advised to speak with a member of The Pandemic Institute team before submitting a proposal. Please do this by emailing contact@thepandemicinstitute.org.

You must describe the proposed work/activity, how it fits within the requirements of this fund, the reasons for the urgent request for funding and your track record as an investigator. The full summary of questions in the survey is included overleaf.

Proposals with a value of £5,000 or less, will be reviewed and we will respond to your request within 7 days of submission.

Proposals with a value over £5,000 will be reviewed and we will respond to your request within 14 days of submission.

Modifications to proposals may be requested where necessary.

Requirements

Proposals submitted to TPI will:

- Include two or more of TPI founding partners.
- Have a Principal Investigator based at a TPI founding partner institution.
- Make a convincing case of the urgency to undertake the research or activity.
- Justify why the research/activity needs to start within a timescale which cannot be accommodated by other funding calls.
- Be clear why the research/activity could not have been proposed earlier, describe how the research/activity takes advantage of an unanticipated, time-limited opportunity and be deliverable for a total cost £50,000 or less.
- Provide a robust case for value for money.
- Be for a duration of up to 12 months.
- Have a study team established and ready to start work if the application is successful.
- Have a start date no later than four weeks from the date of award notification.
- Have strong links to one or more of TPI's five strategic pillars listed below:
